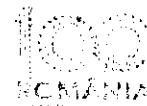

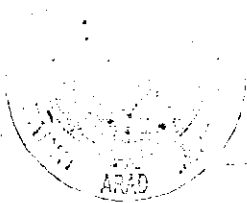
1. Industrie alimentară I - cu durata de 3 semestre, 90 de credite ECTS, învățământ cu frecvență.
